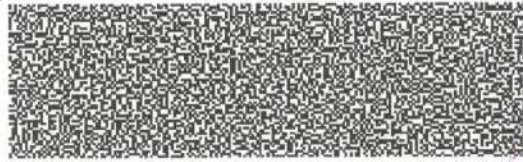

The Principal Name of the Business shall be '**DIYADEEPA ENTERPRISES**'.

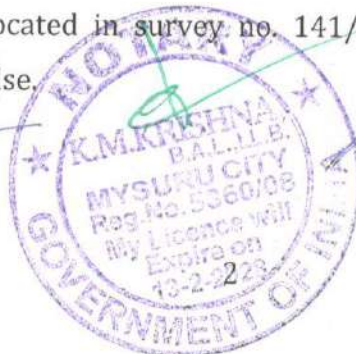
**2. BUSINESS ACTIVITY**

## 9. BORROWING

## 13. ARBITRATION





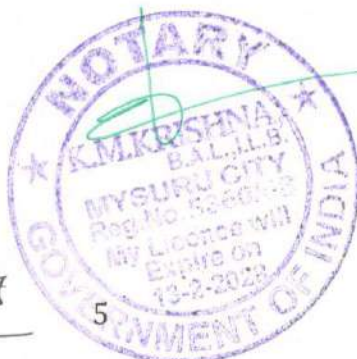
